3. February 25, 2015 (Wednesday) - Last day to declare to seek office in writing.
4. March 4, 2015 (Wednesday) - Membership meeting – Nominations for Executive Board & Officers from the floor. All nominations then final and closed.
5. March 9, 2015 (Monday) - 5 P.M. – CCAFT Office, Draw for position on ballot.
6. March 10-30, 2015 (Tuesday - Monday) – Ballot prepared for distribution.
7. April 1, 2015 (Wednesday) - Ballots mailed out to members.
8. April 15, 2015 (Wednesday) - Ballots counted by Election Committee.
9. April 18, 2015 (Saturday) - Election Committee publicizes election results.
10. May 1, 2015 (Friday) - New Executive Board takes office.
